## MINUTES OF THE

## DISTRICT DEVELOPMENT COMMITTEE MEETING FOR THE MONTH OF APRIL/2023 HELD ON 30/05/2023 AT 11.00 A.M. IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE, BARPETA

The list of officers present is enclosed at Annexure-I

The meeting was presided over by Shri Aayush Garg, IAS, Deputy Commissioner, Barpeta

After the welcome address the meeting threadbare reviewed department wise follow up action in the light of discussion incorporated in the minutes of the last District Development Committees Meeting held on 18/04/2023.

The Chairman reviewed the progress of departmental schemes as follows:-

- 1. PHE:- The Chairman instructed the Executive Engineer, PHE Division, Barpeta to examine the bills/Vouchers etc. submitted by the contractor against the works done in the last flood and submit revised proposals of the actual fund. The Chairman also informed the Executive Engineer, PHE Division, Barpeta to check the raised platform and to submit report immediately.
- 2. Social Welfare:- In a query by the Chairman regarding progress of the project of Pakabetbari Model Anganwadi Centre, the Block Development Officer Pakabetbari Dev. Block informed the house that 25% of works had already been completed. The Chairman instructed the BDO, Pakabetbari Dev. Block to complete the Model Anganwadi Centre within 15 days positively. The Chairman also instructed the BDO, Pakabetbari Dev. Block to submit a detailed report before next District Development Committee Meeting.
- 3. <u>APDCL</u>:- The Technical Assistant, APDCL, Barpeta informed the house that there are around 29 nos. of AWCs which do not have permanent house due to the effect of erosion. The Chairman

instructed the AGM, APDCL, Barpeta to consult with the Addl. Deputy Commissioner, (Social Welfare) Barpeta for proposals of alternative AWCs.

- 4. <u>Health</u>:- In a query by the Chairman regarding progress of the Kholabandha PHC which was needed to be repaired, the Block Development Officer, Gomafulbari Dev. Block informed the Chairman that the repairing work will start from tomorrow i.e. from 31<sup>st</sup> May/2023. The Chairman also instructed the Project Director, DRDA, Barpeta to provide fund for this purpose under 15<sup>th</sup> Finance Commission,
- 5. <u>Agriculture</u>:- The Chairman instructed the District Agriculture Officer, Barpeta to organize a review meeting to discuss about the various schemes being implemented in the district.
- 6. Water Resources Division:- The Executive Engineer, Water Resources Division, Barpeta informed the house that 2(two) nos. of schemes have already been completed and 2(two) nos. of schemes are going on out of 4(four) nos. of schemes under SDRF till date and the physical progress of the works is 44%. The Chairman expressed dissatisfaction on the progress of remaining 2(two) nos. of schemes. The Chairman instructed the Executive Engineer, Water Resources Division, Barpeta to physically verify the aforementioned schemes of the Harijan Channel and submit a detailed report about physical progress of ongoing schemes and others problem by 31/05/2023 positively.
- 7. Miscellaneous:- The Chairman instructed all Block Development Officers to collect the data about Child Marriage in consultation with the department of Health, Social Welfare & Education immediately. The Chairman warned the BDOs that if the one Child Marriage is found to have occurred under their jurisdiction, the concerned GP Secretary will be suspended. The Chairman also instructed Shri Parikshit Thoudam, IAS, Assistant Commissioner, Barpeta to verify the data as submitted by the Block Development Officers.

The Chairman instructed the department concerned to prepare separate list of centrally sponsored and State sponsored schemes and submit Action Taken Report in this regard.

In a query by the Chairman regarding Teenage Pregnancy, the Chairman instructed the Block Development Officer, Pakabetbari and Mandia Dev. Block to cross verify the nos. of Teenage pregnancy with the Health & Social Welfare department as per format received from the Chief

- Executive Officer, Zilla Parishad Barpeta and to prepare a list of G.P. wise detail report from 6 months and submit the same immediately.
- 8. <u>Amrit Sorovar:</u> The Chairman instructed to complete all the schemes under Amrit Sorovar within 31/06/2023 positively and all the items under the scheme may be cross verified by the Technical Officers of different departments and submit report accordingly. The Chairman also instructed all concerned departments to submit demand under MGNREGA if any necessity for new structure.
- 9. <u>Chief Minister's Dashboard</u>:-The Chairman instructed all heads of Departments to fulfill the targets as per Deputy Commissioner's Monitorable indicators immediately.
