MINUTES OF THE
DISTRICT DEVELOPMENT COMMITTEE MEETING FOR THE MONTH OF
JANUARY & FEBRUARY, 2023
HELD ON 13/03/2023 AT 11.00 A.M. IN THE CONFERENCE HALL OF DEPUTY
COMMISSIONER'S OFFICE, BARPETA

The meeting was presided over by Shri Nabajyoti Ojha, ACS, District Development Commissioner Barpeta

After the Welcome address, the meeting thereafter reviewed the department wise follow up action in the light of discussion incorporated in the minutes of the last District Development Committee Meeting held on 13/01/2023.

The Chairman reviewed the progress of departmental schemes as follows:-

1.PHE:-

In a query by the Chairman regarding progress of various schemes, the Executive Engineer PHE Division, Barpeta informed the house that a total 1757 numbers of Running Water Arrangement in Schools have already been completed out of 1892 numbers under Jal Jeevan Mission (JJM) & the remaining 135 numbers are in progress. He also informed that a total 1379 numbers of Running Water Arrangement in AWCs have already been completed out of 1507 numbers under JJM. The remaining 128 numbers are in progress.

The Executive Engineer PHE Division, Barpeta informed that a total 145252 numbers of FHTC have already been achieved out of 287732 numbers under JJM. The remaining 142480 numbers are in progress.

2.PWD (ROADS):-

In a query by the Chairman regarding Land problem encroached by the locals in the market area of Kayakuchi Bazar, the Executive Engineer, PWD-Barpeta-Baghbar & Chenga Territorial Road Division Barpeta informed the house that the Land problem has been solved through a meeting with the officials and local market committee.

3.Social Welfare:-

In a query by the Chairman regarding proposed AWC at Kukarpar, the District Social Welfare Department, Barpeta informed the house that a letter has already been sent to the Director of Social Welfare Department, Guwahati for taking necessary action as there is no VGR land in the proposed AWC at Kukarpar.

4.APDCL:-

In a query by the Chairman regarding electricity connection to the AWCs, Smti. Geetashri Lachit, ACS, Addl. Deputy Commissioner (Social Welfare) Barpeta informed the house that 50 nos. of electrified connections were verified randomly and out of which 18 nos. have been found completed. The Technical Assistant, APDCL, Barpeta informed the house that the remaining will be completed within this week. The Chairman instructed the Technical Assistant, APDCL, Barpeta to submit a detail report before the next District Development Committee's Meeting.

5.Health:-

In a query by the Chairman regarding MMR & IMR status of Barpeta district, the Joint Director of Health Services Barpeta informed the house that a review meeting was held on MMR & IMR. The Status of MMR & IMR of Barpeta district as follows:-

The Joint Director of Health Services, Barpeta also informed the house that month wise Delivery done status of Newly functional against 19 nos. of Delivery Point are as follows:-

6. Agriculture:-

The District Agriculture Officer, Barpeta informed the house that a review meeting was held on PM-Kishan with the Circle Officers regarding farmers registration and increasing the average rate of Paddy procurement.

The District AH & Veterinary Officer, Barpeta informed about the requirement of green fodder for the cattle and the animals, the Chairman instructed the Circle Officer to select at least 100 bighas of high land areas under his jurisdiction so that fodder plantation can be possible without being wasted during the rainy seasons. He also added that the plantation should be completed for a minimum of 100 bighas of land under the supervision of the BDOs.

The District AH & Veterinary Officer, Barpeta informed the house that 500 Bighas of land is available in the Barapeta Farm for Green Fodder for Cattle & other animal. The AH & Veterinary Officer, Barpeta also informed that there is no fund available to bear the cost. The Chairman requested Chief Executive Officer, Zilla Parishad, Barpeta to provide funds.

7. Water Resources:-

The Executive Engineer, Water Resources Division, Barpeta informed the house that 10 nos. of project has already been completed out of 14 nos. of project under SDRF. The remaining 4 nos. of ongoing project will be completed before Bohag Bihu. In a query by the Chairman regarding progress of Harijan scheme, the Executive Engineer, Water Resources Division, Barpeta informed that Plan & Estimate has already been prepared and the work will be started soon.

8. Handloom & Textile:-

The Chairman instructed the concerned Circle Officer to inspect the Powerloom products particularly Gamocha, Mekhala, Chadar etc. before Bihu along with the Handloom & Textile officials.

9. e-Shamiksa:-



The Chairman instructed all the concerned Heads of department to submit up to date Action Taken Report on CM. Monitorable Target (Hard and Soft copy) within 15th March/2023 to the T&D Branch, Deputy Commissioner's Office, Barpeta through email for uploading the same.

10. C.M. Conference:-

The Chairman informed all concerned Heads of department that the Chief Minister's Conference will be held on April, 2023, the Chairman instructed all concerned Heads of department to submit action point report as per minutes within 7 days.
