MINUTES OF THE  
DISTRICT DEVELOPMENT COMMITTEE MEETING FOR THE MONTH  
OF DECEMBER, 2022  
HELD ON 13-01-2023 AT 11.00 A.M. IN THE CONFERENCE HALL OF  
DEPUTY COMMISSIONER'S OFFICE, BARPETA

The list of officers present is enclosed at Annexure -I.

The meeting was presided over by Shri Aayush Garg, IAS, Deputy Commissioner, Barpeta.

After the Welcome address the meeting thereafter reviewed department wise follow up action in the light of discussion incorporated in the minutes of the last District Development Committee Meeting held on 09/12/2022.

The Chairman reviewed the progress of departmental scheme as follows:

**1.PHE** :-In a query by the Chairman regarding progress of various schemes, the Executive Engineer PHE Division, Barpeta informed the house that 1757 numbers have already been achieved out of 1892 no.s for Running Water Supply in schools under JJM. The EE PHE division, Barpeta also informed that 1379 number have already been achieved out of 1507 number for Running Water Supply in AWCs under JJM. The remaining 128 number are in progress.

The EE under PHE Division, Barpeta added that there are about 45 pending cases for AWCs and 9 for Schools under JJM for the connection of water supply. The Chairman instructed the EE PHE Division, Barpeta to submit

the all new pending proposals to the Schools (126 proposals) and to AWCs (83 proposals) within the time frame of 15 days.

**2. PWD (ROADS)**-The EE PWD (Barpeta, Baghor & Chenga Territorial Road Division) informed the house that a road of about 9 meter near the market area of Koyakuchi is required for the construction. While the road of 4 meters nears the market area was encroached by the locals. The Chairman instructed to organize a meeting among the concerned Circle Officer, officials of PWD Roads and the Local Market Committee under the guidance of Addl. DC, Revenue.

**3. SOCIAL WELFARE (WOMEN AND CHILD DEVELOPMENT)**-The District Social Welfare Department, Barpeta informed that the proposed AWC at Kukarpar could not be executed due to VGR land and another site named Gaskuchi has been selected. The Chairman instructed to the DSWO, Barpeta to write a letter to the Director of Social Welfare (Women & Child Development), Guwahati for the same. The concerned CO is instructed to verify the proposed land.

**4. APDCL**-The Chairman instructed the Technical Assistant, APDCL, Barpeta to submit the list of already electrified connection to the AWCs in the month of December which is about 2099 in numbers to the Addl. Deputy Commissioner (Social Welfare), Barpeta. The Chairman further added that 50 centers out of these electrified connections will be randomly verified by the concerned Assistant Commissioners. The Chairman also instructed to submit the facts of these 50 verified locations by the Addl. Deputy Commissioner (Social Welfare), Barpeta in next DDC meeting.

**5. Directorate of Health & Family welfare**-The Joint Director of Health Services, Barpeta informed that the total number of testing cases under JE was 17 till December, 2022. The Chairman instructed the JDHS to submit the review report of MMR within 5 days and added that there will be a presentation about the monthly track report of MMR from next DDC meeting onwards.

**6. Agriculture-**The Chairman instructed that there will be a PM Kisan Meet in every circle of Barpeta. A review meeting is fixed on 17<sup>th</sup> January, 2023 with Dist. Agriculture officer regarding farmers' registration and how to increase the average rate of paddy procurement.

The District AH & Veterinary officer, Barpeta informed about the requirement of green fodder for the cattle and other animals. For this, the Chairman instructed the Circle Officer to select at least 100 bighas of high land areas under his jurisdiction so that fodder plantation can be possible without being wasted during the rainy seasons. He also added that the plantation should be completed for a minimum of 100 bighas of land under the supervision of the BDOs in the mentioned period before the next DDC meeting. It is informed in the house that RINA is one of the best maize for the animals which costs Rs 50/kg in the local market. The Chairman instructed the Dist. Agriculture Officers to submit a proposal regarding the costing of the production at per bigha of land for the particular maize product Rina.

**7. Water Resource-**The EE Water Resource, Barpeta mentioned that about 14 projects of SDRF are on work as of now. He further informed the house that the letter to the contractor was proceeded for the Beki Project. The Chairman added that the problems regarding erosional aspect for the Beki Erosion Project under FREMAA will be resolved within 15 days and the concerned Circle Officer is looking after the matter. The EE, Water Resource, Barpeta informed the house that the materials for non erosion projects are being accumulated in the Howly area initially and it will be sent to the specified area mentioned for the project. The Chairman asked the concerned Circle Officer to visit the site about the work of contractors regarding accumulation of materials and how far the work has been completed so far. The Chairman asked the CO to put a detail report within 7 days about the matter. Further, according to the EE, WR Division, Barpeta there are about 4 numbers of projects working under the department in the Sorbhog region; out of these approximately 80% of work has been

completed. The Chairman instructed the concerned CO to visit the area and will be reviewed by the next DDC meeting.

The Chairman reviewed the Dashboard and Indicators of the **Chief Minister's Monitorable Targets** with the concerned departments as follows-

**Agriculture**-The DAO, Barpeta informed that the target for the month of January was about 15000 under PM Fasal Bima Yojana. While the Chairman instructed to complete the target for 24000 by January.

**Health**-The Joint Director of Health, Barpeta has mentioned that 19 numbers of new delivery points will be added within one week and it can be showed by a presentation in the next DDC meeting.


**PMAY**- The Chairman instructed the BDOs to submit the curtailment list within 5 days.

**PHE**-.According to EE PHE Division, Barpeta out of 1507 projects about 1379 projects have been completed. The Chairman instructed to submit the entire list.

**APDCL**- The Chairman said that there is query about the new proposals sent by the Secretary, AEDA to Barpeta and they are willing to get new proposals from every district including Barpeta. The Chairman added that regarding the matter, the APDCL officials can take the help of PWD (Electricals) but the sole responsibly has to be taken by APDCL only. The Chairman further instructed the Technical Assistant, APDCL, Barpeta to have a conversation with the officials of AEDA and to submit at least 6 proposals for the consideration made by AEDA for 6 circles in Barpeta in the next DDC meeting.

**Action: All Concerned Department**
