No.BDD-413/2024/Survey/24: In pursuance of the letter vide No. B/NKD/DSR/2259 Dated: 28/08/2024 issued by the Divisional Forest Officer, North Kamrup Division, Rangia, in compliance of the Hon'ble NGT order Dated. 23rd July,2024 and Govt. Notification No. ECF No. 535050/852 dated. 17/09/2024 issued by the Special Chief Secretary (Forest), the District Level Committee is hereby constituted to oversee and preparation of District Survey Report (DSR) for mining of minor minerals under Barpeta District comprising of the following members.

The main objective of preparation of District Survey Report (as per the sustainable Sand Mining Management Guideline,2016) is to ensure the following:

Identification of area of aggradations or deposition where mining can be allowed and identification of area of erosion and proximity to infrastructural structures and installation where mining should be prohibited and calculation of annual rate of replenishment and allowing time for replenishment after mining in the area.

The Committee will prepare the District Survey Report after visiting its sites of mining area of Barpeta district and submit the district survey report in prescribed format enclosed as Annexure III to the State Level Environment Impact Assesment Authority (SEIAA).

The following shall be the role & responsibilities of the Committee:

1. The District Committees shall visit all the minor mineral mining areas/potential mining areas indicated in the DSR and give geo-tagged photographs, images etc. of the inspected areas.
2. During the preparation of DSRs, each District Committee has to follow the guidelines enumerated in the **MoEF & CC guidelines of 2016,2018 and 2020 for mining of minor minerals.**
3. The Committee shall propose necessary inputs/corrections in the draft DSRs submitted by the concerned DFOs and shall make them available in Public Domain for 21 days in the district portal.

4. If no objection against the draft DSR is received within the time period of 21 days, the DSR shall be finalized by the District Level Committee and submit it for examination evaluation and appraisal to State Expert Appraisal Committee (SEAC) and within 6 weeks recommendation shall be forwarded to SEIAA for approval

This order will come into force with immediate effect.
