ORDER

In pursuance of the District Weather Warning issued by the India Meteorological Department (IMD), Government of India, and the Regional Meteorological Centre, Guwahati, forecasting thunderstorms accompanied by lightning and spells of heavy to very heavy rainfall over isolated places in Barpeta District, and considering the prevailing weather conditions, it has become imperative to adopt appropriate precautionary measures in the interest of public safety.

Whereas, due to incessant rainfall during the past few days, the water level of the River Brahmaputra and its tributaries has risen alarmingly, posing a significant threat to human life, property and public safety.

Now, therefore, in view of the prevailing flood situation and in exercise of the powers conferred under Section 30(2)(xviii) of the Disaster Management Act 2005 I, Nabadeep Pathak, ACS, District Commissioner & Chairperson, District Disaster Management Authority, Barpeta, being satisfied that immediate preventive measures are necessary to avert any potential disaster, hereby prohibit the operation of all departmental and private boats/vessels engaged in ferry services within Barpeta District with immediate effect, except those deployed for essential and emergency services, until further orders.

The Assistant Engineer, Inland Water Transport (IWT), Guwahati and the Sectional Officer (i/c), Baghbar–Goalpara Ferry Service, shall ensure strict implementation of this order and submit a daily compliance report to the Chief Executive Officer, DDMA, Barpeta.

This Order shall come into force with immediate effect and shall remain in force until further orders.
