TERMS AND CONDITIONS:

- The tenders will have to be accompanied by up to date GST and Income Tax from the competent Authority.
- 2) Non-refundable of bid processing fee of Rs.1000/- (Rupees One thousand) only in cash and EMD/Bid Security of Rs.5,000/- (Rupees five thousand) only are to be deposited in Bank Draft pledged in favour of District Commissioner, Barpeta.
- 3) The rate should be quoted inclusive of all taxes.
