

TERMS AND CONDITIONS :

- 1) Non-refundable of bid processing fee of Rs.1000/- (Rupees One thousand) only and EMD/Bid Security of Rs.20,000/- (Rupees twenty thousand) only are to be deposited in cash or Bank Draft pledged in favour of District Commissioner, Barpeta.

8) District Election Officer has the right to accept or reject any or all tenders without assigning any reason thereof.


