In view of urgent nature of work, the quotations will be received upto **3.00 PM of 18/03/2026** and will be opened on the same day in the office Chamber of the Election Officer, Barpeta in presence of the quotationer or their representatives. Quotations will have to be deposited at the tender box kept at Election Office, Barpeta, during office hours on working days.



TERMS AND CONDITIONS :

- 1) Non-refundable of bid processing fee of Rs.1000/- (Rupees One thousand) only in cash and EMD/Bid Security of Rs.10,000/- (Rupees ten thousand) only are to be deposited in Bank Draft pledged in favour of District Commissioner, Barpeta.
- 2) The rate should be quoted inclusive of all taxes.
- 3) The quotationer must attach the photo copy of Firm's Govt. Registration Certificate/ GST Registration Certificate, PAN Card, trade License from MB, IT returned of last 3 (three) years and Bank Account Number with the Quotation.

- 4) L1 rate for each item will be decided through the tender. All work orders will be issued in L1 rate only. For supply of each listed item, preference will be given to the bidder who has quoted L1 rate for that particular item.
- 5) Documents to be furnished along with rate.
 - i) GST return for the last 3 (three) Financial Year.
 - ii) IT return for the last 3 (three) Financial Year.
 - iii) PAN Card.
 - iv) Similar earlier experience, if any.
- 6) All the printing works should be completed within the stipulated time to be fixed by the undersigned.
- 7) Rates once accepted will not be changed and will remain for hiring valid for a period of one year.
- 8) Payment will be made as and when fund is received from the Govt.
- 9) The specification of the postal ballot is as per guidelines. The paper required for printing will be supplied by the office of the undersigned.
- 10) The details of the items can be collected from the Election Office, Barpeta
- 11) District Election Officer has the right to accept or reject any or all tenders without assigning any reason thereof and has the right to fix the price of any materials as per prevailing market rate.
- 12) The experienced firms under Barpeta District will be preferable considering election urgency
- 13) No other printing and entry of unauthorized person will be allowed while printing of postal ballot papers


