- 5. Non-refundable of bid processing fee of Rs.1000/- (Rupees One thousand) only in cash and EMD/Bid Security of Rs.50,000/- (Rupees fifty thousand) only are to be deposited in Bank Draft pledged in favour of District Commissioner, Barpeta
- 6. The rate should be quoted inclusive of all taxes.
