1. The Bidders must be a registered APWD (Electrical) Contractor.
2. Certificate of experience of having successful competition of similar works has to be submitted
3. Value of work is approximate and may differ in the formal work order for which no claim will be entertained
4. **The work order will be 10% below estimated rates**
5. Non-refundable of bid processing fee of Rs.1000/- (Rupees One thousand) only in cash and EMD/Bid Security of Rs.30,000/- (Rupees thirty thousand) only are to be deposited in Bank Draft pledged in favour of District Commissioner, Barpeta
6. The rate should be quoted inclusive of all taxes.
7. The quotationer must attach the photo copy of Firm's Govt. Registration Certificate/ GST Registration Certificate, PAN Card, trade License from MB, IT returned of last 3 (three) years and Bank Account Number with the Quotation.
