**Role of Aspirational Blocks Fellow:**

The Aspirational Blocks Fellow will be positioned as a critical link between the Block Level Officials (BLOs) of Mandia Development Block and NITI Aayog. His/Her primary responsibilities will include:

1. Collaborating with Block Level Officials to design and execute development strategies aligned with ABP thematic areas.
2. Conducting regular field visits to assess project implementation, address challenges, and collect ground level insights.
3. Analyzing data and providing evidence based recommendations to BLOs, District level Officials to optimize developmental initiatives.
4. Organizing workshops, awareness campaigns, and skill-building programs to empower local community.
5. Keeping States and NITI Aayog abreast with the issues, challenges and need for support.

**Terms and Conditions:**

1. The Fellow is hereby offered provisional deployment to the post of Aspirational Block Fellow in Mandia Development Block, Barpeta District, Assam. The post of Aspirational Block Fellow is purely temporary the tenure of which will initially span a period of one year. The performance of the fellow is subject to appraisal and the program allows for a one-year extension of the fellowship contingent upon the fellow's satisfactory performance.
2. Aspirational Block Fellow will receive a fixed monthly stipend of Rs. 55,000.00 (Rupees fifty five thousand) only for a period of 12 (twelve) months.
3. The Aspirational Block Fellow is expected to deliver his/her services at any time if and when required.
4. The Fellow will work closely with the Block Level Officials of Mandia Aspirational Block. Regular reporting of the fellow's activities and progress to the District Commissioner, Barpeta, will be essential part of the job.
